The Taser Training Academy is pleased to announce that we are organising a Taser Master Instructor Course within the premises of the Madrid Municipal Police Training Facility, to support Law Enforcement and Military agencies throughout EMEA (Europe, Middle East, Africa) plus other agreed Countries on Application.

Participation in this course is only open to active employees of authorities with public security responsibilities, such as police, customs and justice, or active military personnel with police duties. (An identity document and a letter of confirmation is required).

The language of the course will be Spanish and English, although depending on the number of participants we have ability to run the course with French, Italian or German speaking groups.

The participation of Master Instructor candidates in the five days of instruction is compulsory (Mon-Fri, arrival before the start of the course on Monday 8.00hrs). The courses will take place daily from 08.00 to 17.00 hrs. However, this may change depending on the availability of the training facilities. The training ends on Friday, 9th July at 16.30 hrs. Participants who leave before the end of the course will NOT have fulfilled the requirements to receive the Taser Master Instructor certificate!

On the first day, all participants will make a short presentation to introduce themselves and give an overview of their involvement with TASERs, their application and operational use, as well as the legal classification of TASERs in their organisation, in order to facilitate the exchange of best practices and the development of networks within the participant Group. This presentation should not last more than 5 minutes and can be made in the native language or in English. (Translation will be provided by an Axon Trainer).

This course includes information and applications on all available Taser devices (TASER 7, X2 and X26P), data management, forensics and maintenance, body cameras, evidence.com/Commander software for evidence management and gives an overview of Axon's product portfolio.

The participation fee for the Master Instructor course is

1495 Euros (plus statutory VAT) per participant.

and includes all training materials, access to the necessary Taser devices and cartridges, a voluntary Exposure (if desired) as well as lunch and a coffee breaks. An evening networking event is also planned. Transport between the hotel and the training venue as well as accommodation are not included in the price, hotel facilities (below) will be available close to the venue.

- The nearest Airport is BARAJAS AIRPORT in Madrid. A transport from Municipal Police of Madrid will be taking attendees arriving Sunday the 4th of July 2021.
- All participants should book their flights to arrive at the Barajas Airport between 15h and 22h as last transportation trip to the hotel.

First-time participants in the Master Instructor course must meet the following requirements:

Be an active member of the staff of an authority with public security duties, such as police, customs and justice, or be active in military service (5 years of professional experience, proof of service card and letter of confirmation).

If the Agency is already using tasers:

2 years of experience as a TASER instructor, in law enforcement or military.

Currently certified TASER instructor by a Master Instructor.

Successful completion of 12 courses for TASER users.

Many authorities in the region are starting to use Axon / TASER products. In this case, participation is possible if you have the appropriate professional experience as an operations/ Use of Force / Self Defence trainer or weapons Instructor. A proven track record in self-defence, use of force or firearms is essential and will be considered on an individual basis.



Conditions for ALL participants:

ALL participants MUST bring a NEGATIVE PCR test done no more than 72h before the start of the course or an official Covid Vaccination Certificate. This is mandatory, at the beginning of the course all documents will be required.

Participation in all drills and physical activities during the course (full service clearance required).

Please do not submit the form if you are unable to participate in a physically demanding training environment or if you are restricted in your department/not cleared for full duty by your department.

DOCUMENTS REQUIRED FOR AN APPLICATION FOR PARTICIPATION:

1. Completely filled in and signed application form and disclaimer of liability.
2. An official letter of confirmation from the applicants authority/organisation about active employment and support for participation in this course.

First-time participants must also submit the following documents:

1. a current curriculum vitae indicating the training experience
2. If possible: documentation of at least 12 successfully completed courses for TASER users (list of training dates and number of participants).

All documents must be received for review together by email. Please do not submit them separately, as these applications will not be considered until all materials have been received.

PCR test and Vaccination Certificates can be sent by email 24h prior the start of the course. These COVID documents will be required AGAIN prior to the start of the course.
